KNOW ALL MEN BY THESE PRESENTS, that R. M. Gaffney

in consideration of One Dollar and division of property-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William P. Bogan, his heirs and assigns, forever:

All my right, title, interest and estate, the same being an undivided one-half interest therein, in and to all that piece, parcel or strip of land 15.24 feet in width situate, lying and being on the Easterly side of S. C. Highway No. 291 and being a portion of Lots 4 and 5 as shown on a plat of the property of J. H. Sitton dated April 13, 1955 and recorded in the R. M. C. Office for Greenville County in Plat Book II, Page 127.

Grantor and Grantee and others heretofore owned, as tenants in common, Lots 4 and 5, as shown on the above mentioned plat. From time to time, portions of these lots were sold off and the interest of other co-tenants purchased by Grantor and Grantee so that the remaining property owned by them constituted a 10 foot strip of Lot 4 and a 28.48 foot strip of Lot 5. It is the intention of Grantor and Grantee to divide equally this remaining property so that Grantee will own in fee simple the Northern one-half of said property and Grantor the Southern one-half thereof. See deed of even date wherein Grantee conveys to Grantor his undivided one-half interest in the Southern one-half of this property. For derivation, see, among others, deeds recorded in Book 882, Page 279; Book 769, Page 434; Book 640, Page 87; and Book 600, Pages 15 and 21.

This conveyance is made subject to all restrictions, set back lines, roadways, easements and rights of way, if any, appearing of record, on the premises or on the recorded plat, which affect the property hereinabove described.
