ALL MY RIGHT, TITLE AND INTEREST IN THE FOLLOWING DESCRIBED PROPERTY:

All that certain piece, parcel or lot of land with the improvements thereon lying, and being situate in Fairview Township, County of Greenville, State of South Carolina, and containing 0.017 acre according to a plat made by T.H. Walker Jr. dated JULY 2, 1974 and to be recorded in the RNC Office for Greenville County and being more fully described according to said plat to-wit.

Beginning at an iron pin at the Northwest corner of said property on the west side of drive way, thence S34-01E 35.1 feet to a stake on the east side of driveway, thence S16-31E 90 feet to a stake on same side of driveway, thence S34-01W 35.1 feet to an iron pin back on the west side of driveway, thence N16-31W 90 feet to an iron pin, said pin being the point of beginning. These are the measurements of the driveway, that is the Western section of the property owned by Carroll and Virginia Ann Goodwin.

The following measurements are the meets and bounds of the property owned by Carroll and Virginia Ann Goodwin.

Beginning at a stake on the eastern side of said driveway, thence S34-01E 273.6 feet to an pin at the North East corner of said property and the North West corner of property owned by Cecil F. Eskew, thence S1-09W 33.45 feet to an iron pin at the South East of said property, the same pin being the South West corner marker of property owned by Cecil F. Eskew thence N84-01W 246.2 feet to a stake on the East side of driveway, thence S16-31E 90 feet to an iron pin, this pin being the point of beginning.
