We, Harold Sightler and W. H. Caldwell, as Trustees for Greer Baptist Camp Meeting Association, do hereby acknowledge receipt of the sum of Ten and 00/100 (\$10.00) and the resignation of Peter Caprice, Jr., D.O.T.M.S. paid to Grantor by Billy Kelly, Meeting Association, and do hereby further acknowledge and declare that by these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, Billy Kelly, his heirs and assigns, forever:

All of that parcel or tract of land in Chick Spring Township of Greenville County, South Carolina, about 1½ miles southwest of the City of Greer, lying on the west side of a new cut County Road which leads from the Harrett bridge road to the Cherry Creek Branch, bounded on the North by lands of now or formerly W. L. Jones, on the South and East by lands now or formerly of Paul L. and Pearl L. Henriksen, and on the West by lands now or formerly of Frank Jarron, having the following courses and distances according to a plat thereof made by C. C. Jones, S.E., dated January 16, 1972, i. wit:

BEGINNING on an iron pin, corner now or formerly with Frank Jarron, who runs thence S. 33-35 E. 381 feet to a stake; thence N. 75-45 E. 420 feet to a stake on edge of said new cut road; thence along and with the western edge of said road as follows: S. 13-20 E. 170 feet, S. 20-50 E. 100 feet, S. 26-38 E. 100 feet, S. 31-43 E. 100 feet and S. 35-46 E. 270 feet to a stake; thence S. 39-46 W. 123 feet to a stake; thence S. 13-1 E. 420 feet to a stake on South side of branch; thence S. 31-25 W. 202 feet to a stake; thence N. 39-30 W. 55 feet to a point in center of branch; thence N. 39-30 W. 625 feet to the beginning corner, containing Twelve (12) Acres, more or less, and being a portion of that land conveyed to us by deed on record in the R.R.C. Office for Greenville County, Book 451, at Page 31.

BEGINNING at an iron pin in the middle of a broken chain on the aforesaid plat and running thence S. 39-30 W. 195 feet to an iron pin; thence S. 31-25 W. 300 feet; thence S. 13-19 E. 225 feet, more or less, to an iron pin; thence S. 11-31 W. 102 feet, more or less, to an iron pin; thence N. 39-30 W. 115 feet to an iron pin in the middle of the circuit, the point of beginning.

TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the Grantee and Grantee's Heirs Successors and Assigns forever. AND Grantor does hereby bind Grantor and Grantor's Successors Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
