the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto T. J. Segars, his heirs and assigns forever:

All that certain piece or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 8 of a subdivision known as Sunnymede as shown on Plat thereof prepared by Woodward Engineering Service, March, 1955, and recorded in the RMC Office for Greenville County in Plat Book II at Page 109, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Chestnut Street, joint front corner of Lots No. 7 and 8, and running thence along the joint lines of said Lots S.27-32W. 227.9 feet to a point on Brushy Creek; thence along the meanders of Brushy Creek, a traverse line being S.52-03E. 71.7 feet to a point on Brushy Creek, the joint rear corner of Lots Nos. 8 and 9; thence along the joint line of said lots N.25-51E. 237.8 feet to an iron pin on the Southern side of Chestnut Street; thence along the Southern side of Chestnut Street N. 59-56W. 61.1 feet to an iron pin, the BEGINNING corner.
