All that piece, parcel or lot of land in Greenville Township, County and State aforesaid, known and designated as Lot No. 5 of Block A of Summit View Subdivision, as shown on Plat recorded in the R. M. C. Office, County and State aforesaid, in Plat Book A, pages 74 and 75, and being more particularly described as follows:
