It is the intention of the Grantor by this instrument to convey to E. D. And the Grantor does hereby bind himself and his successors to warrant and forever defend the said premises to the said E. D. Sloan, Jr., his heirs and assigns, against himself and his heirs and assigns, and against every person whomsoever lawfully claiming or to claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
