WHEREAS, The South Carolina State Highway Department pursuant to authority contained in Section 33-124, Code of Laws of South Carolina, 1962, authorizing the release of the premises hereinbelow described, which premises are no longer required for purposes of the South Carolina State Highway Department,

KNOW ALL MEN BY THESE PRESENTS, That the South Carolina State Highway Department, for and in consideration of the sum of One Dollar (\$ 1.00) to it in hand paid, receipt of which is hereby acknowledged, does hereby remise, release and quit-claim unto Charles B. Suttles and Nellie G. Suttles, their heirs, and assigns all its right, title, interest in or to the following described property;

All that piece, parcel or tract of land North of the city of Travelers Rest, County of Greenville, State of South Carolina, situate on the southern side of S. C. Route 11 and the eastern side of U. S. Route 25 at their intersection, all of which is shown on a sketch, a copy of which is attached hereto and made a part hereof and being more particularly described as follows:

Beginning at a point, which point designates the intersection of the 37½ foot right of way line for S. C. Route 11 and the original 25 foot right of way line for U. S. Route 25, thence easterly along the above mentioned right of way for S. C. Route 11 for 50 feet to a point, thence in a southwesterly direction to a point on the original 25 foot right of way line for U. S. Route 25, which point is 50 feet south of the intersection of the aforementioned rights of way for S. C. Route 11 and U. S. Route 25, thence along the original 25 foot right of way lines for U. S. Route 25 for 50 feet to point of beginning.

This being a portion of the right of way conveyed to the South Carolina State Highway Department by Right of Way Condemnation Proceedings dated May 15, 1950, from Mr. Charles B. Suttles and Nellie G. Suttles, which proceedings are recorded in the South Carolina State Highway Department.
