O'BRIEN, HER HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Northwesterly side of Fernwood Drive, near the City of Greenville, South Carolina, being known and designated as Lot No. 5 on plat of Section 4, Edwards Forest recorded in the RMC Office for Greenville County, South Carolina, in Plat Book JJJ at Page 82 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Fernwood Drive, said pin being the joint front corner of Lots 4 and 5 and running thence with the common line of said lots N. 33-15 W. 175 feet to an iron pin, the joint rear corner of Lots 4 and 5; thence S. 56-45 W. 100 feet to an iron pin, the joint rear corner of Lots 5 and 6; thence with the common line of said lots S. 33-15 E. 175 feet to an iron pin on the Northwesterly side of Fernwood Drive; thence with the Northwesterly side of Fernwood Drive N. 56-45 E. 100 feet to an iron pin, the point of beginning.

THIS being the same property conveyed to the Grantors by a certain deed recorded in the RMC Office for Greenville County in Deed Book 896 at Page 222. THIS conveyance is subject to all restrictions, setback lines, easements, roadways and rights-of-ways, if any, affecting the above described property.
