in consideration of One Thousand Five Hundred and No/100-----(\$1,500.00)-----in full

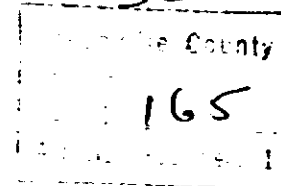
