County of Greenville, State of South Carolina, including approximately  
700 feet 6" pipe; 920 feet 2" pipe; 1 - 6" valve; 5 - 2" valves and 1 - fire  
hydrant, and is shown on a drawing entitled "Westminster Company to  
Commissioners of Public Works of the City of Greenville, S. C.", dated August  
13, 1975, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said  
lines and all rights of way and easements necessary or incident to the  
operation, maintenance, repair or replacement of said water lines and  
appurtenances.
