KNOW ALL MEN BY THESE PRESENTS, that

DAVID PAVLUK AND JAMES D. WOZNICK

in consideration of TWO THOUSAND SIX HUNDRED TEN AND 00/100-----(\$2,610.00)-- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JACK METCALF AND ETHEL METCALF, THEIR HEIRS & ASSIGNS FOREVER:

ALL that lot of land situate in the State of South Carolina, County of Greenville, near Travelers Rest, South Carolina containing 1.96 acres and being shown and designated as Lot 8 on a plat of Property of Jack and Ethel Metcalf, dated July 24, 1975, prepared by W. R. Williams, Jr., Surveyor, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Northridge Road, joint front corner of lots 8 and 9 and running thence S. 81-01 W., 457.7 feet to an iron pin; thence along the line of Property of Pavluk, et al, N. 1-03 E., 220 feet to an iron pin; thence N. 88-32 E., 446.1 feet to an iron pin on Northridge Road; thence with said Northridge Road as follows: S. 0-45 W., 35 feet to an iron pin and S. 1-09 E., 125 feet to an iron pin, being the point of beginning.

This is a portion of the property conveyed to David Pavluk and James D. Woznick by deed recorded in the RMC Office for Greenville County in deed book 1014 at page 820.

This conveyance is made subject to the following restrictive covenants:

1. Dwelling Must be set back a minimum of 35 feet from line of said lot.
2. Only one single family residence allowed on this lot; minimum house size 1400 square feet, living area
3. Single wide mobile home not allowed. Double wide on permanent brick or block foundation allowed. Must have a minimum of 24" ground clearance at the lowest point. Minimum double wide size 24' x 55'.
4. Temporary single wide mobile home allowed for up to one year during construction of permanent house. Foundation for house must be constructed before mobile home can be placed on property.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
