the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Joe W. Hiller, his heirs and assigns forever.

ALL that piece, parce. or lot of land, situate, lying and being in the City of Simpsonville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 36, on plat entitled "Section I, Powderhorn", dated July 26, 1973, most recently revised March 1, 1974, prepared By Piedmont Engineers and Architects, recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4X at Page 95, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Canebreak Lane at the joint front corners of Lots 35 and 36 and running thence along the joint line of said lots, N. 66-45 W., 110 feet to a point at the joint rear corner of said lots; thence along the line of Lot 36 and the common area of Powderhorn, N. 8-28 E., 122.3 feet to a point; thence running N. 87-38 E., 90.00 feet to a point at the joint rear corner of Lots 36 and 37; thence, along the joint line of said lots, S. 8-30 E., 142.5 feet to a point at the joint front corner of said lots; thence with the arc of the cul-de-sac of Canebreak Lane, S. 58-53 W. 20.0 feet to a point; thence continuing with said cul-de-sac, S. 32-12 W., 20 feet to a point, the point and place of beginning.
