ACKNOWLEDGMENT

WHEREAS, James J. Harrington and Zerena S. Harrington are the owners in fee simple of a certain tract of land located in Greenville County, South Carolina and a plat of which said tract of land is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5N, at Page 3, and

WHEREAS, James J. Harrington and Zerena S. Harrington desire to construct a dwelling on said land and it will be necessary to install a septic tank system on said land in order to insure sanitary conditions for the purpose of disposing of sewage waste, and

WHEREAS, the Greenville County Health Department has examined said property and is of the opinion that there may be some difficulty in getting a septic tank system to properly work on said land, but is willing to issue a permit for such system if said owners so desire,

NOW, THEREFORE, Know All Men By These Presents, that James J. Harrington and Zerena S. Harrington request the Greenville County Health Department to issue them a permit for the installation of a septic tank system on the land owned by them in the County of Greenville, State of South Carolina, and a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5N, at Page 3. It is further agreed and understood by the said James J. Harrington and Zerena S. Harrington that they are fully aware that a septic tank system may not satisfactory operate on said land because of poor soil conditions and subsurface and surfact water problems on the lot. The said James J. Harrington and Zerena S. Harrington further acknowledge that they are fully aware of the fact that there is a distinct possibility that any septic tank system installed on the said land will not function adequately and that they will be responsible for maintaining the system according to all rules and regulations of the Greenville County Health Department regarding the disposal of sewage waste. This is to further acknowledge that the said James J. Harrington and Zerena S. Harrington intend to construct a dwelling on said land for the purposes of maintaining a permanent residence thereon.
