REAL PROPERTY AGREEMENT

BANK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

 - 3. The property referred to by this agreement is described as follows:

All that certain piece, parcel or tract of land, situate in Brushy Creek Township, in School District Yumber One (1), Anderson County, South Carolina, containing .5 acre, more or less and fronting in a westernly direction on a county road, a distance of 110 feet, and running back therefrom on its southern boundary a distance of 227 feet, and running backtherefrom on it northern boundary a distance of 227 feet, and having a width at the of 110 feet, and being more particularly shown and designated on that certain plat of Webb Surveying and Marring Company, Greenville, South Carloina, dated July 20, 1963, which plat is of record in the Office of the Clerk of Court for Anderson County, S.C. at Flat Bk. 56 at rg hb. (ever)

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby athorized to rely thereon.
