the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

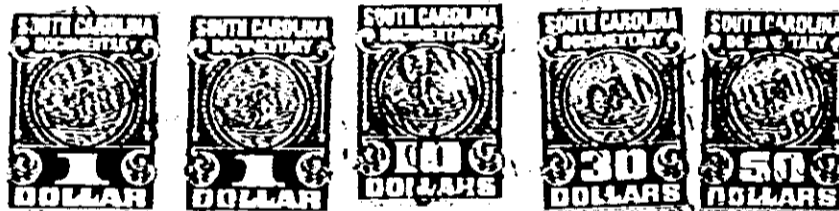
KENNETH W. FISH and SUSAN G. FISH, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, at the corner of Old Mill Road and Holly Road, being shown as Lot No. 48 on plat of Edwards Forest Heights, recorded in Plat Book 000, at Page 89, and being more fully described as follows:

BEGINNING at an iron pin at the joint front corner of Lots 47 and 48 and running thence with the line of said lots, North 54-38 East 165 feet to the joint rear corner of said lots; thence South 35-22 East 134.3 feet to an iron pin on Holly Road; thence along Holly Road, South 54-38 West 145 feet to the corner; thence around the corner, the chord of which is South 80-22 East 28.3 feet to an iron pin on Old Mill Road; thence along said road, North 35-22 West 115 feet to the point of BEGINNING.
