KNOW ALL MEN BY THESE PRESENTS, that I, J. E. TILLEY,

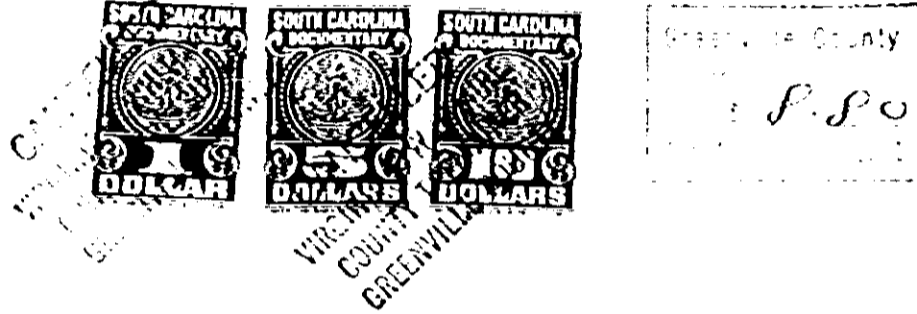
in consideration of EIGHT THOUSAND & NO/100 (\$8,000.00) - - - - - Dollars,
