ROSAMOND ENTERPRISES, INC., Its Successors and Assigns:

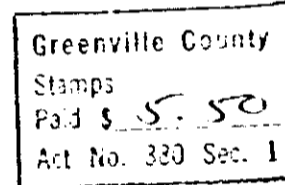
