All of that certain lot of land with the buildings and improvements thereon in the County of Greenville, State of South Carolina, in Austin Township, and within the corporate limits of the City of Mauldin, being known and designated as Lot No. 118 of a subdivision known as Glendale a plat of same being recorded in the R.M.C. Office for Greenville County in Plat "QQ" at pages 76 and 77, and having the following metes and bounds:

BEGINNING at a point on the northern side of Drury Lane at the joint front corner of Lots Nos. 117 and 118 and running thence N. 11-16 E. 170.9 feet to the joint rear corner of Lots Nos. 117 and 118; thence S. 78-44 E. 145 feet to a point on the western side of Rowan Street at the joint corner of Lots Nos. 109 and 118; thence with the western side of Rowan Street, S. 11-16 W. 145.9 feet to a point; thence following the curvature of the northwestern intersection of Rowan Street with Drury Lane (the chord of which is S. 56-16 W. 35.3 feet) to a point; thence with the northern side of Drury Lane, N. 78-44 W. 120 feet to the point of beginning, being the same conveyed to Mac Smith by deed of Odell Shaver recorded in the R.M.C.
