KNOW ALL MEN BY THESE PRESENTS, that GERALD W. BALLARD

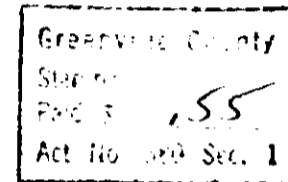
in consideration of -----FOUR HUNDRED AND NO/100 (\$400.00)----- Dollars,
