All my right, title and interest, being an undivided one-half interest, in and to:

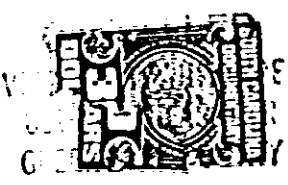
