- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: Reginning on an iron pin on the southern edge of Acorn Avenue 250 feet from Woodruff Road and running thence south 26-25 east 200 feet to an old iron pin; thence south 63-35 west 80 feet to an old iron pin; thence north 26-25 west 200 feet to an iron pin on the southern edge of Acorn Avenue; thence with the southern edge of said avenue north 63-35 east 80 feet to the beginning point.

This is the same property as conveyed to the Grantor gerein by deed from Addie W. Long, said deed being duly recorded in deed book hOS at page h.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
