DONALD RAY DAVIS and PATRICIA HODGES DAVIS, their heirs and assigns forever:

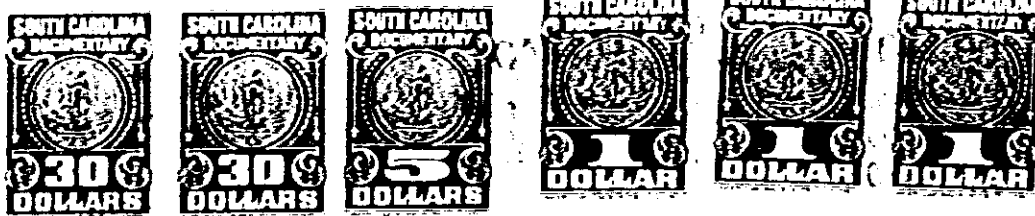
