thence along the center of said Railroad North 86-33 West 1,205.8 feet to a point; thence North 3-27 East 57.5 feet to an iron pin on the Northern side of the right-of-way of P & N Railroad; thence North 3-27 East 75.6 feet to an iron pin on the Southeastern side of the right-of-way of Rutherford Road; thence across the Southeastern half of said right-of-way and across Rutherford Road to a point on the Northeastern side of Rutherford Road, the point of beginning.

This property is conveyed subject to the rights-of-way for Rutherford Road and for P & N Railroad, both of which traverse a substantial portion of the Southeastern half of the property, as shown on a plat referred to above. This conveyance is also made subject to any other easements, rights-of-way, or other encumbrances of record or visible on the premises.
