release unto R. David Kennerly, his heirs and assigns, forever;

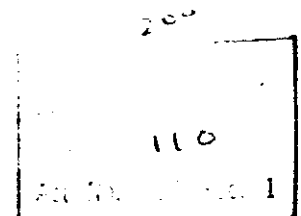
ALL that certain piece, parcel or lot of land, with all improvements thereon,

County in Plat Book 4R at Page 19, revised by Plat recorded in Plat Book 4X
at Page 3, and having according to said plat, the following metes and
bounds, to-wit:

BEGINNING at a point located on the southemside of the right-of-way of
Winding Way, a joint corner of Lots 140 and 141; thence S.12-40 E. 152.2
feet to a point; thence S. 76-40 W. 68.1 feet to a point; thence N. 17-14
W. 150.0 feet to a point located on said right-of-way; thence along said
right-of-way N. 71-12 E. 18.0 feet; thence N. 75-29 E. 62.0 feet to the
