All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known as Lot No. 5 Chisolm Trail of Section 2, Parkins Lake Development, Greenville, S. C. according to a plat made October 22, 1962 by R. K. Campbell, Engineer, and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "YY" Page 93, and being more particularly described as follows:

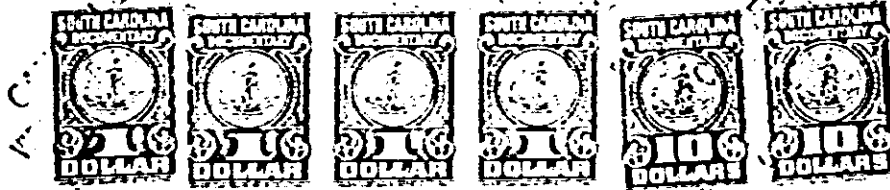
BEGINNING at an iron pin on the Southeast side of Chisolm Trail, joint front corner of Lots 5 and 6 and running thence along Chisolm Trail N. 33-55 E. 150 feet to an iron pin, joint front corner of Lots 4 and 5; thence along the line of Lot 4 S. 56-05 E. 185 feet to an iron pin, joint rear corner of Lots 4 and 5; thence S. 33-55 W. 150 feet to an iron pin, joint rear corner of Lots 5 and 6; thence along the line of Lot 6 N. 56-05 W. 185 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 723, Page 105, and any easements or right-of-ways of record which affect said property.
