All that lot of land with improvements situate, lying and being on the Eastern side of York Drive (formerly known as Blythwood Drive) in Greenville County, South Carolina, being shown as the Southern portion of Lot No. 100 on Map 2 of Camilla Park, made by W. J. Riddle, Surveyor, dated December, 1943, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book M, Page 85, and having according to a more recent survey made by Campbell & Clarkson Surveyors, Inc., dated October 1969, the following metes and bounds, to-wit:

Beginning at an iron pin on the Eastern side of York Drive at the joint front corners of Lots Nos. 99 and 100, and running thence N.84-15E., 98.5 feet to an iron pin; thence along the rear lot line of Lot No. 104, N.9-28W. 80.6 feet to an iron pin; thence a line through Lot No. 100, S.72-35W. 108.9 feet to an iron pin on York Drive; thence along the Eastern side of York Drive, S.19E. 60 feet to an iron pin, the beginning corner.

Being the same property conveyed to the Grantor by deed in Deed Book 1027, at page 970 recorded in the R. M. C. Office for Greenville County, South Carolina. —161—241—7—511

As a part of the consideration for this conveyance the Grantees expressly assumes and agrees to pay the balance due on a certain note and mortgage in the favor of the Federal National Mortgage Association and recorded in the R. 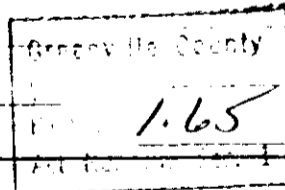

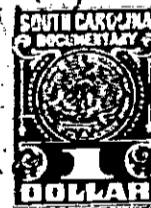
