ALL OF OUR RIGHT, TITLE AND INTEREST IN AND TO:

All that lot of land situate on the northwestern side of Deborah Lane in the County of Greenville, State of South Carolina, being shown as a tract containing .038 acres on a plat of the property of Terry N. Mills, et al, dated October, 1975, prepared by Dalton and Neves Co., Engineers, recorded in Plat Book 5-J, at Page 65 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Deborah Lane at the corner of Lot No. 5 of Lakewood Subdivision and running thence with Lot 5 N. 67-51 W. 145.5 feet to an iron pin; thence N. 2-20 E. 9.5 feet to an iron pin; thence S. 69-04 E. 165 feet to an iron pin on Deborah Lane; thence with said Lane S. 75-14 W. 20.4 feet to the point of BEGINNING.
