in consideration of One (\$1.00) Dollar and satisfaction of mortgage having a balance of Dollars, Thirty-Five Thousand, Eight Hundred Seventy-Three and 18/100 (\$ 35,873.18) the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto First Federal Savings and Loan Association of Greenville, S. C., its successors and assigns forever:

All that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Golden Grove Circle, being known and designated as Lot No. 18 as shown on plat entitled GOLDEN GROVE ESTATES, SECTION I, dated September 7, 1971, prepared by R. D. Garrison, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at Page 1, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Golden Grove Circle at the joint front corner of Lots Nos. 17 and 18 and running thence with the common line of said Lots, S 11-16 W 210 feet to an iron pin; thence running S 78-44 E 120 feet to an iron pin at the joint rear corner of Lots Nos. 18 and 19; thence running with the common line of said Lots, N 11-16 E 210 feet to an iron pin on the southwestern side of Golden Grove Circle at the joint front corner of Lots Nos. 18 and 19; thence running with the southwestern side of Golden Grove Circle, N 78-44 W 120 feet to the point of beginning.

This conveyance is made subject to any restrictions, reservations, zoning ordinances or easements that may appear of record, on the recorded plat (s), or on the premises.

This deed is an absolute conveyance of title in effect as well as in form and is not intended as a mortgage, trust conveyance, or security of any kind. The consideration therefore is full release of all debts, notes, obligations, costs and charges heretofore (continued on back page)
