the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Cornelia C. Hawkins, her heirs and assigns,

All that tract of land in the county of Greenville, state of South Carolina, containing 2.29 acres on the southwest side of Hawkins Road, as shown on plat made by Carolina Engineering and Surveying Company Dec. 15, 1975, entitled "Survey for I. W. Coleman" recorded in plat book page of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at a nail in the center of Hawkins Road, corner of property formerly owned by Helen Coleman, and running thence N. 41-00 E. 373 feet to an iron pin; thence turning N. 87-28 E. 194 feet to an iron pin corner of tract being conveyed to I. Walter Coleman; thence with the line of said tract S. 26-03 W. 538.8 feet to a nail in the center of Hawkins Road; thence with the center of said road N. 49-44 W. 79.9 feet to a nail; thence continuing with the center of said road N. 45-10 W. 200 feet to the point of beginning.
