KNOW ALL MEN BY THESE PRESENTS that I, We, MICHAEL TED WHITMIRE and CINDY ROGERS WHITMIRE of the County of Greenville in the State aforesaid, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration to us in hand paid by the United States of America, acting through the Administrator of the Farmers Home Administration, the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said United States of America, the following described property situated in Greenville County, State of South Carolina, to-wit:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the northern side of Chesley Drive and being known and designated as Lot No. 69 on a plat of THE VILLAGE, Section I, recorded in the RMC Office for Greenville County in Plat Book 4-R at Page 52, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Chesley Drive at the joint front corner of Lots 69 and 70 and running thence N. 47-27 E. 132.78 feet to an iron pin; thence S. 76-19 E. 45.39 feet to an iron pin; thence S. 14-21 W. 148.88 feet to an iron pin on Chesley Drive; thence with said Drive, N. 58-27 W. 124.60 feet to the point of beginning.
