the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto M. G. PROFFITT, INC., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the westerly side of Sugar Creek Lane, near the City of Greenville, South Carolina, being known and designated as Lot No. 132 on plat entitled "Map 4, Section One, Sugar Creek", as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 5D, at page 72, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Sugar Creek Lane, said pin being the joint front corner of Lot Nos. 131 and 132; and running thence with the common line of said lots S. 82-55-12 W. 211.30 feet to an iron pin, the joint rear corner of Lot Nos. 131 and 132; thence S. 37-18-12 E. 183.70 feet to an iron pin, the joint rear corner of Lot Nos. 132 and 133; thence with the common line of said lots N. 59-17-50 E. 156.75 feet to an iron pin on the westerly side of Sugar Creek Lane N. 30-44-00 W. 23.63 feet to an iron pin; thence continuing with said Lane N. 18-54-24 W. 75.83 feet to an iron pin, the point of beginning.
