in consideration of Two Thousand, Eight Hundred and No/100 (\$2,800.00)----- Dollars,

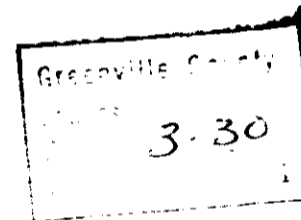
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Henry N. Pace and Natalie J. Pace, their heirs and assigns forever:
