the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Furman Bull and Lucille Bull

All that lot of land situate on the northern side of a 20 foot drive in the County of Greenville, State of South Carolina, being shown as a 2 acre tract on a plat of the property of Nettie Campbell and Sloan C. Campbell dated January 15, 1976, revised January 26, 1976 prepared by Piedmont Engineers, Architects, and Planners recorded in Plat Book 5-0, at Page 50 in RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit: - 355.646.1-1-11

BEGINNING AT AN IRON PIN on the northern side of a 20 foot drive which iron pin is located at the northeastern terminus of said 20 foot drive and running thence with the northern side of said 20 foot drive N. 82-08 W. 45.02 feet to an iron pin; thence still with said 20 foot drive S. 75-31 W. 45.98 feet to an iron pin; thence still with said drive S. 64-21 W. 109 feet to an iron pin; thence N. 3-50 E. 505.18 feet to an iron pin; thence S. 84 E. 200 feet to an iron pin; thence S. 6 W. 433 feet to the point of beginning.

Together with an easement for ingress and egress by means of a 20 foot drive which connects the aforescribed property with Old Mill Road as shown on the aforesaid mentioned plat.

This is a portion of the property conveyed to the grantors by deed recorded in Deed Book 1021, at Page 627 in the RMC Office for Greenville County.

Grantees are to pay 1976 county property taxes.

The above described property is conveyed subject to all restrictions, easements, rights-of-way and zoning ordinances existing or of record which affect the title to the above described property together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs, successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs, successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs, successors and assigns against the grantor(s) and the grantor's(s') heirs, successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

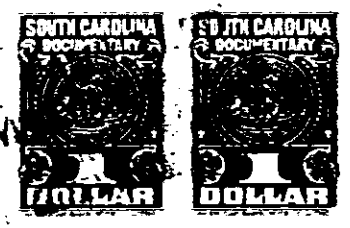
