KNOW ALL MEN BY THESE PRESENTS, that Leonard L. Adler and Sue G. Adler

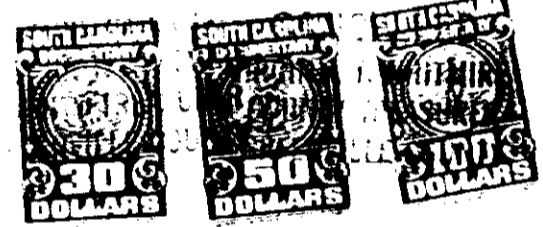
in consideration of Ninety thousand and no/100ths-----(\$90,000.00)-----Dollars,
