in consideration of Twenty-Five Thousand and No/100 (\$25,000.00)-----Dollars,

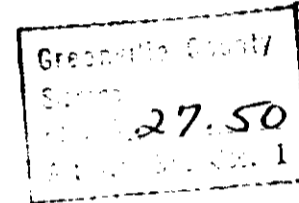
