Office for Greenville County in Plat Book 4-N at page 24.

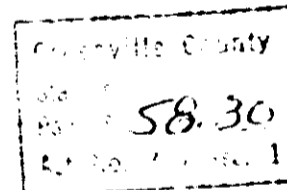
