KNOW ALL MEN BY THESE PRESENTS, that I, Royce Woods Floyd,

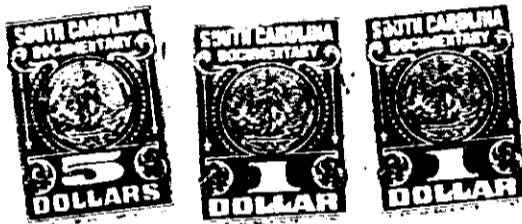
in consideration of Three-thousand, three-hundred and 00/100 (\$3,300.00) Dollars,
