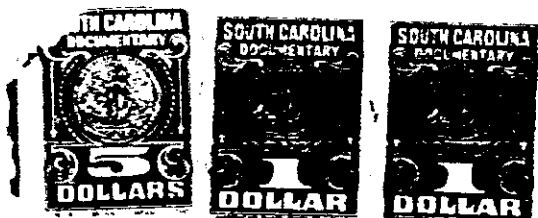

BEGINNING at an iron pin at the Northeastern corner of the intersection of White Horse Road and Old White Horse Road and running thence with the Eastern side of White Horse Road N. 22-41 W. 308.6 feet to an iron pin; thence continuing with the Eastern side of White Horse Road N. 24-35 W. 180 feet to an iron pin; thence with the line of a .881 acre tract N. 76-57 E. 289.1 feet to an iron pin on the Western side of Old White Horse Road; thence with the Western side of Old White Horse Road, the following courses and distances: S. 4-40 E. 150 feet to an iron pin, thence S. 3-13 E. 284.7 feet to an iron pin, thence S. 24-55 W. 38 feet to an iron pin and thence S. 65-50 W. 108.5 feet to the point of beginning. - 357 - 503.7 - 1-23
