KNOW ALL MEN BY THESE PRESENTS, that we, Bob E. Wheeler and Brenda D. Wheeler

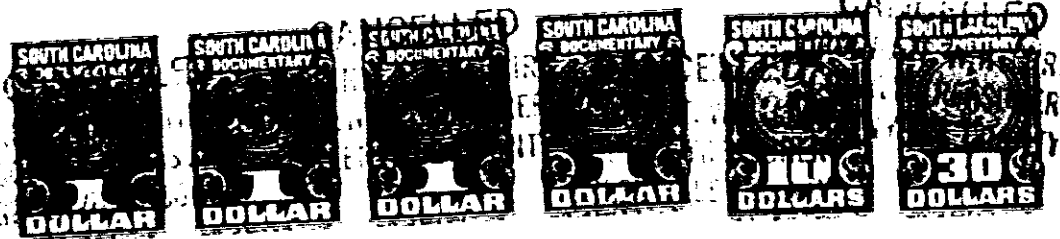
in consideration of Twenty-Two Thousand and No/100-----(\$22,000.00)----- Dollars,
