THIS WARRANTY DEED, made this 9th day of April, 1976,

of Greenville County, State of South Carolina, Grantor(s);
and Thomas R. Morton and Mary T. Morton
of Greenville County, State of South Carolina, Grantee(s);

WITNESSETH: That the said grantor(s) for and in consideration of the sum of Twenty-one Thousand Eight
Hundred and No/100----- Dollars (\$ 21,800.00),

to it in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, has

granted, bargained, sold and conveyed and by these presents does grant, bargain,
sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the
survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of

reversion, the following described land, lying and being in the County of Greenville

State of South Carolina, to-wit:

ALL of that piece, parcel, or lot of land, situate, lying and being in the
State of South Carolina, County of Greenville, and being known and
designated as Lot No. 161 of Sunny Slopes Subdivision, Section Two,
according to a plat prepared of said property by C. O. Riddle, Surveyor,
February 8, 1971, and recorded in the R.M.C. Office for Greenville County,
South Carolina, in Plat Book 4R, at Page 67, and according to said plat
having the following courses and distances, to-wit:

BEGINNING at a point on the edge of Duncan Road, joint corner of Lots 160
and 161 and running thence with the common line of said lots, N. 71-36 W.
144.3 feet to a point; thence, N. 15-30 W. 55 feet to a point; thence,
N. 79-53 E. 147.6 feet to a point on the edge of Duncan Road; thence run-
ning with said Road, S. 10-14 E. 62 feet to a point on edge of Duncan Road;
thence continuing with said Road, S. 4-16 W. 63.6 feet to a point on the
edge of Duncan Road, the point of beginning.

The within property is conveyed subject to all easements, rights-of-way,
protective covenants and zoning ordinances.
