ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile north of Chick Springs, lying 690 feet west of the St. Mark Road, and on the north side of the McConnell Road, and having the following courses and distances, to-wit:
