the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Sugar Creek Lane, near the City of Greenville, South Carolina, being known and designated as Lot No. 130 on plat entitled "Map No. 4, Section One, Sugar Creek" as recorded in the RMC Office for Greenville County, S. BEGINNING at an iron pin on the northwesterly side of Sugar Creek Lane, said pin being the joint front corner of Lot Nos. 129 and 130 and running thence with the common line of said lots N. 43-45-00 W. 157.48 feet to an iron pin, the joint rear corner of Lot Nos. 129 and 130; thence S. 45-16-51 W. 125.08 feet to an iron pin, the joint rear corner of Lot Nos. 130 and 131; thence with the common line of said lots S. 67-39-28 E. 183.33 feet to an iron pin on the northwesterly side of Sugar Creek Lane; thence with the northwesterly side of Sugar Creek Lane on a curve the chord of which is N. 34-17-46 E. 76.64 feet to an iron pin; thence continuing with said Lane N. 46-15-00 E. 22.81 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property, and is subject to a 25 foot sewer easement along rear lot line and a 5 foot drainage and utility easement along side and rear lot lines.
