KNOW ALL MEN BY THESE PRESENTS, that I, Virginia Crozer Leopard

in consideration of Ten Dollars and Love and Affection for my Fiance Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Hilliard C. Henderson and His Heirs and Assigns forever,

ALL that certain lot of land in the County of Greenville, State of South Carolina, about one miles eastward from Chick Springs, being known and designated as Lot No. 67 of the T.W. Dill Estate, according to survey and plat by S.C. Moon, Surveyor, dated October 1940, and a more recent survey of R.K. Campbell and having the following courses and distances, to-wit:

BEGINNING at an old iron pin on the westernside of SUBER ROAD, joint corner of Lots Nos. 66 and 67 and runs thence with the common line of these two lots, S. 68-52 W. 244.6 feet to an old iron pin; thence with the common lines of Lots Nos. 67 and 7k, S. 24-10 E. 121 feet to a point on the northern bank of the old Chick Springs Road (iron pin back on line at 3 feet); thence with the northern edge of the said Old Chick Springs Road, N. 52-40 E. 263.2 feet to an iron pin on the intersecting corner of the said two road; thence with the western edge of the Suber Road, N. 37-39 W. 50 feet to the beginning corner.

The grantee assumes and agrees to pay the mortgage of Aike Loan and Security Co., recorded in the RMC Office for said County in Mortgage Book 965, page 355, in the original amount of \$8,000.00 with a balance due in the amount of \$6,287.74.

The grantor assigns and sets over to the grantee the insurance policy and Escrow account held in connection with the above loan by the Mortgagee.
