- Mississippi No. 031
Washington and Edison Streets
Greenville, Washington County, Mississippi

The North 125 feet of Lot 5, Block 6 of the Fourth Addition to the City of Greenville, Washington County, Mississippi, as the same appears of record on a Plat filed in the office of the Chancery Clerk of Washington County, Mississippi.

- South Carolina No. 003
Augusta Street
Greenville, Greenville County, South Carolina

Beginning at a point on the East right of way of Augusta Street 210 feet Southeast of Douglas Drive; running thence North 60° 47' East 150 feet; thence South 29° 13' East 198 feet; thence South 60° 47' West 150 feet; thence North 29° 13' West 198 feet to the beginning corner, being Lots 71, 72, 73 and 74 of plat filed in Plat Book "G", pages 191-192. There are iron pins at all corners.

Central Street
Knoxville, Knox County, Tennessee

Situate in the 7th (formerly 2nd) Civil District of Knox County, Tennessee, within the 17th Ward of the City of Knoxville, Tennessee, being known and designated as all of Lots 2, 3, 4 and 5, Block 3, of the Oakwood Addition to the City of Knoxville, as shown on the map of the same of record in Map Book 5, page 187, in the Register's Office for Knox County, Tennessee, and being more fully described as follows: Beginning on an iron pin located in the Northeast line of Central Street, said iron pin marking the front corner of Lots 5 and 6 and being North 47° 30' West, 50 feet from the point of intersection of the Northeast line of Central Street with the Northwest line of Springdale Avenue; thence along the Northeast line of Central Street, North 47° 30' West, 200.0 feet to an iron pin marking the corner of Lots 1 and 2; thence with the line of Lots 1 and 2, North 42° 30' East, 140.0 feet to an iron pin located in the Southwest line of a 10-foot alley; thence with said alley, South 47° 30' East, 200.0 feet to an iron pin marking the rear corner of Lots 5 and 6; thence with the line of Lots 5 and 6, South 42° 30' West, 140.0 feet to the point of beginning; according to the survey of Batson and Himes, Engineers, Knoxville, Tennessee, dated 10 June 1960.

Chapman Highway and Young High Pike

Situate in the 9th (formerly 3rd) Civil District of Knox County, Tennessee, without the corporate limits of the City of Knoxville, Tennessee, being known and designated as part of Lots 1 and 2, Young's addition to Knoxville, Tennessee, and being more fully described as follows: Beginning at the point of intersection of the Southeast line of Young Avenue with the Northeast line of Chapman Highway right of way; thence with the line of Young Avenue, North 53° 46' East, 131.05 feet to an iron pin corner to Fred Human;
