in consideration of Twenty-two Thousand Nine Hundred Fifty and 00/100 (\$22,950.00) Dollars,

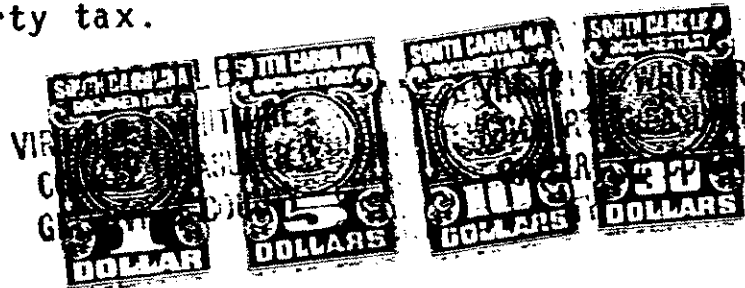
