Harper hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his heirs and assigns forever.

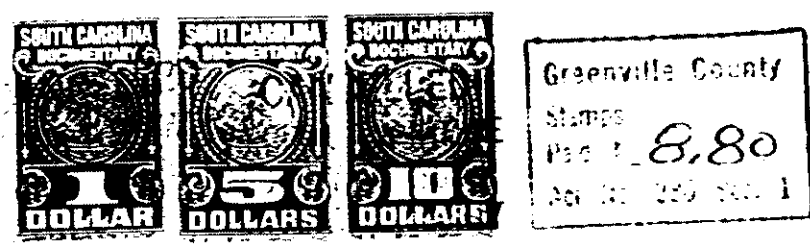
All his right, title and interest, being a one-half (1/2) undivided interest, in that certain piece, parcel or lot of land near the City of Greenville, State of South Carolina, on the southern side of Roper Mountain Road and shown as Lot 29 on plat of Huntington, prepared by Piedmont Engineers and Architects on May 4, 1968, recorded in Plat Book WWW, at Page 23 B in the RMC Office for Greenville County, South Carolina, and having the following metes and bounds:

BEGINNING at a point on the southern side of Roper Mountain Road at the joint front corners of lots 28 and 29, and running thence along the southern side of Roper Mountain Road S 86-25 W 230 feet to the joint front corner of lots 29 and 30; thence along the joint lines of lots 29 and 30 and 30 A S 10-37 E 409.4 feet to a point on the rear line of lot 26; thence thence along the joint line of lots 29 and 26 N 72-01 E 188.3 feet to the joint corner of lots 29, 28, 25 and 26; thence along the joint lines of lots 29 and 28 N 3-57 W 360 feet to the point of BEGINNING.
