the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ZEKE HEMBREE AND ELLA P. HEMBREE, their heirs and assigns, forever,

ALL that piece, parcel, or lot of land, lying and being in Cleveland Township, County of Greenville, State of South Carolina, known as Lot #21, as shown on plat dated January 20, 1962, of the Georgia-Pacific Corporation, and recorded in Plat Book YY, Page 51, and the community known as Pine Ridge, being one of the lots purchased by M. L. Jarrard from Georgia-Pacific Corporation, March 6, 1962, as recorded in Volume 693, Page 459, having the following rates and bounds, to-wit:
