KNOW ALL MEN BY THESE PRESENTS, that The Citizens & Southern National Bank, as Trustee, under the will of Joseph Hull, in consideration of

Sixty One Thousand and No/100-----(\$61,000.00)---Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto CHARLES R. SAMPLE and KATHRYN D. SAMPLE, THEIR HEIRS AND ASSIGNS FOREVER:

All That certain peice, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, and within the corporate limits of the City of Greenville, being known and designated as Lot No. 39 of a subdivision known as Stone Lake Heights, Section 1, according to a plat thereof prepared by Piedmont Engineering Service, June, 1952, and recorded in the R. M. C. Office for Greenville County in Plat Book BB, Page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Lakecrest Drive, the joint front corner of Lots Nos. 39 and 40, and running thence along the joint line of said lots, S. 72-40 E. 220.1 feet to a point on the margin of Stone Lake, the joint rear corner of said lots; thence along the margin of Stone Lake (the traverse line of which is S. 13-02 W. 110.3 feet) to a point on the margin of Stone Lake, the joint rear corner of Lots 38 and 39; thence along the joint line of said lots, N. 72-40 W. 215.8 feet to an iron pin on the eastern edge of Lakecrest Drive, the joint front corner of said lots; thence along the eastern edge of Lakecrest Drive, N. 17-22 E. 110 feet to the beginning corner.

Together with all rights and privileges in and to the bed and waters of Stone Lake as are accorded by law to a riparian owner, including, without being limited to, the right and privilege, as appurtenant to said lot, to go upon and use the waters of said lake for the purpose of engaging in normal aquatic sports such as boating, fishing, and swimming, and the further right to construct and maintain a dock or landing which does not extend farther than 15 feet from the waters edge and is so located as not to interfere with the reasonable use of Stone Lake by any other riparian owner. -519-274.2-1-40

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. office for Greenville County in Deed Vol. 466 at page 279, and is also subject to supplemental restrictions and protective covenants recorded in Vol. 471, at page 23.

The lot above described is also subject to certain easements for the installation and maintenance of public utilities, which easements appear of record in said R. M. C. office.

THIS is the identical property conveyed to the grantors "and Daniel B. Hull, as Trustees under the will of Joseph Hull for Anna W. H. King", by deed recorded in Deed Book 491 at page 407. The said Joseph Hull died testate in Chatham County, Georgia, and named seven (7) successive co-trustees, including Daniel B. Hull, and all of such co-trustees have since died leaving the Grantor as sole Trustee. Reference is hereby made to a copy of such will on file in the Probate Court of Greenville County;
