JAMES E. BURGER, HIS HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the northernmost portion of Lot No. 38 as shown on plat of property of William R. Timmons, Jr., prepared by C. O. Riddle, dated July 1967, which plat is of record in the RMC Office for Greenville County, S.C. in Plat Book 000 at page 193, being more specifically shown on plat entitled "Drawn for E. M. Hanna" prepared by Carolina Surveying Co., dated April 16, 1976, which plat is of record in the RMC Office for Greenville County, S.C. in Plat Book 5S at page 40, and having, according to said latter plat, the following metes and bounds, to wit:

BEGINNING at an iron pin at the intersection of Lots 37 and 38 on the westerly side of Driftwood Drive and running thence down the westerly side of Driftwood Drive, S. 14-52 E., 125 feet to an iron pin; running thence S. 75-08 W., 405.85 feet to an iron pin on county road; thence down said county road, N. 3-34 E., 131.75 feet to an iron pin; joint rear corner of Lots 37 and 38; running thence down joint line of said lots, N. 75-08 E., 364.2 feet to the beginning corner, being the northernmost portion of original Lot 38 and containing 1.10 acres, more or less.

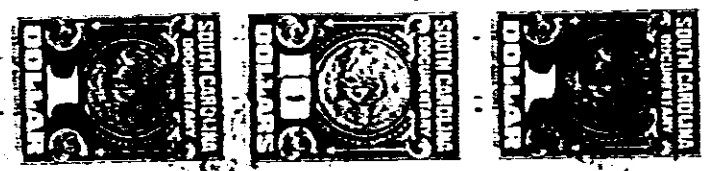
