in consideration of One Thousand (\$1,000.00) - - - - - Dollars,

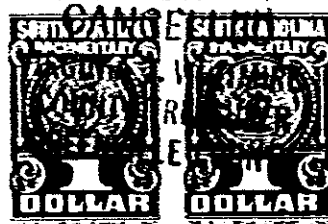

All of our interest in all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being Lot No. 24 as shown on Plat Sec. 5 of Judson Mill Village by Dalton & Neves, Engineers, February 1940, recorded in Plat Book K, Pages 33 and 34, R.
